Whereas the Settlor is desirous of establishing a trust for charitable objects:

And whereas the trustees have, at the request of the **Settlor**, to act as the **FIRST** trustees of the present as testified by their being parties to and executing these presents.

And whereas it is necessary to declare the objects and terms of the charitable Trust being constituted under these presents;

Now this indenture witnesseth as follows :-

1. That in order to effectuate her aforesaid desire, the Settlor has set apart and handed over to the trustees a sum of Rs. Rs. 1,00,000/(One Lack Rupees Only) hereinafter called the Trust fund which expression shall include cash and any other property or investment of any kind whatsoever into which the same or any part thereof might be converted, invested or varied from time to time or which may be acquired by the trustees or may come to their hands by virtue these presents or by operation of law or otherwise howsoever in relation to these presents) and Trustees shall hold and stand possessed of the same upon the trust subject to the powers provisions, agreements and declarations hereinafter contained.

2. That the name of the trust shall be "SIR DAN.S. CHARLES AND MARY EDUCATIONAL & RESEARCH FOUNDATION" and its office shall

for the present be situated at-Belbanwa (Behind-Custom Office)

1. That the objects for which this trust is established are :-

(a) to establish, develop maintain and run School,

- (f) To undertake propaganda, training and education of the masses either of its own or in co-operation with similar agencies working for the cause of all round development of the Society.
- (g) To establish maintain and run studentship, scholarship and render other kind of aid to students including supply of books, stipends, medals, and other incentives to without any distinction as to Cast, Colour, Race, Creed or Sex,
- (h) To establish, develop, maintain and grant aid in cash or other financial assistance to Schools, Colleges, Children welfare centres, maternity homes, and or such other similar charitable institutions in India for the benefit and use of the general public
- (i) To promote, establish, support, maintain or grant aid to institutions for the promotion of science, literature, music drama and fine arts, for the preservation of historical monuments and for the research and other institutions in India having similar object for the benefit of the public in general;
- (j) To establish maintain or grant aid for the establishment of gymnasiums ,sports club, parks ,gardens and rest houses for use of public in general
- (k) To establish maintain or grant aid to homes for the old aged peoples, orphanages ,widows, poor, needy and other such destitute people, orphans, widows and aged people;
- (I) To establish and develop institution for disabled, mentally retarded or physically handicapped persons and to provide them food, education clothing or other help;

- (m) its prant reliaf and assistance to the needy victim during natural calamities such as families, earth quake, flood, fire positiones are and to give donations and other assistance to institution establishments or persons engaged in such relief work.
- (n) To grant aid or rander assistance to other public charitable trusts or institutions.
- (a) To grant sid to repair esmeteries and burisl grounds.
- (v) To function as a Non-communal Trust and as a secular organisation,
- (a) To establish centres for employment generation;
- (r) To confer title on eminent personality in the field of literature, science, education etc.
- (s) To acquire and maintain the movables and immovable properties for achieving said object.
- 4. That the Trust Fund may be sugmented by the Income from the Initial fund and also by donation, and other contributions from time to time.
- That the Trust Fund shall not be applied for any purpose specified in Clause 3 hereinabove.
- 6. That the Trustees shall always maintain proper books of accounts of the Trust which shall be kept at the office of the Trust
- 7: That for the furtherance of the objects of the Trust the Trustees shall have following powers :-
 - (a) To accept any denation, contribution, grant or subscription in each or in kind, from any person(s), body of persons or trust, with or without conditions,
 - (b) To apply the whole or any part of the Income of the Trust fund or accumulations thereto, to any one or more of the objects of the Trust, as the Trustees may in their discretion deem fit from time to time;
 - (c) To convert and deal with the Trust property and/or any investment for the time being,
 - (d) To invest the Trust Fund either in the purpose of mortgage of immovable property or in shares, stock or debenture or other securities and investments or in the deposits with or loan to any company bank, firm or any other person, and to alter, vary or transpose such investments, from time to time at the discretion of the Trustees,
 - (e) To borrow or raise or secure payments of moneys and also to lend money either with or without security.

- (f) To sell, dispose of, alienate or otherwise deal with any Property comprising the Trust Fund,
- (g) To let out demise any immovable property comprised in the Trust Fund for such period and at such rate on such terms and conditions as the Trustees in their discretion may think fit,
- (h) To open account in the name of Trust, Trustees and/or Institutions run/conducted by the Trust with a Bank or Banks to operate such Bank account and to give instructions to the Bank and to provide for opening and operation of such accounts by one or more of the Trustees or an


